## **COMMISSIONS IN THE UNITED STATES**

This is not a complete list of commissions. To our knowledge, there is no published master list of commissions. But this list, which is updated and expanded from the appendix list in *Human Relations Commissions* (2020, Columbia University Press) may be the most comprehensive available. Note that some of the state commissions have regional offices that support state-level commission functions, and not all of these regional offices are listed below. These listed commissions have varying degrees of web presence, and some may now be defunct or experience variable funding status. Some, like the City of Los Angeles Civil and Human Rights Department, are entirely new entities funded in response to civil uprisings related to police brutality and calls for racial justice. These new entities were founded after our book went to press, necessitating an updated commission list on our book's virtual page. Please feel free to contact us with any requested changes to this list.

List "type" corresponds to the three designations described in our book. While all commissions can play an advisory role, most are also differentiated between quasi-judicial enforcement of antidiscrimination laws, intergroup dialogue facilitation, or both of these additional functions. As such, we specify quasi-judicial and facilitator type differences in the table.
